COURSE DESCRIPTION

This course covers the history/evolution/principles and contemporary applications of criminal law. Topics include substantive law, classification of crimes, parties to crime, elements of crimes, matters of criminal responsibility and critical theory of crime.

From property crimes to homicide, this course will explore the fundamental elements to crimes in the United States, their historical progression, constitutional limitations as well as the specific defenses to them. In addition, the course will survey the general principles of criminal liability including the ideas of mens rea and actus reas. Moreover, students will learn the various degrees of criminal liability including intentional, reckless and negligent conduct its concurrence and causation as well as conspiracy and the concepts of vicarious and strict liability.

The course will explore crimes against persons, including general and sexual assault, aggravated assault and homicide as well as crimes against the public order, including disorderly conduct, vagrancy, panhandling, gang activity and certain victimless crimes. In addition, the course will examine the elements associated with property crimes, including burglary, larceny, theft, vandalism and fraud. Finally, the course will look at various crimes against the government, including treason, sedition, sabotage, espionage and terrorism.

- 1. The student will be able to explain the nature, purpose, and function of criminal law.
- 2. The student will be able to identify and discuss the basic elements of a crime.
- 3. The student will be able to identify and discuss parties to crime, vicarious liability, punishments, sentencing, justification and excuse defenses.
- 4. The student will be able to explain constitutional limitations in criminal law.

Reading the book carefully along with the Powerpoint lecture will ensure the provide a greater understanding of the material.

Discussion Boards There will be a weekly discussion board called You Decide from the assigned chapter(s). Students are to read the passage and thoroughly answer the question(s) in no less than 250 words. Your initial post is worth 30 points. After you post, you will be able to see your classmates' posts. Please choose at least two of your classmates' posts to expound on and respond to their post in no less than 100 words each. Each response post is worth 10 points. To earn full credit, you must adhere to the word count and submit a substantive post and response to two of your peers. The discussion board for the week is due each Saturday 11:59pm.

<u>Chapter Quizzes</u> There will be a weekly quiz from the assigned chapter(s) consisting of 20 multiple choice questions, each question is worth 1 point. The quiz for the week is due each Saturday 11:59pm.

Exams The will be 3 exams, 1 midterm exam and 1 final exam for a total of 5. All of the exams will consist of multiple-choice questions except the final which will consist of 10 essay question from chapters 15 & 16.
