TO: Presidents and Secretary-Treasurers of Affiliated State Associations

The AVA House of Delegates which is the annual business meeting of the American Vocational Association will be held in the auditorium of the Minneapolis Vocational School, Minneapolis, Minnesota, 3:00 P.M., Thursday, December 10, 1964.

Enclosed you will find a copy of the Articles of Incorporation and By-Laws of the AVA. I wish to call your attention to Article IV-B "Governing Bodies" which sets forth the regulations under which delegates are seated and the procedure for naming them.

Attached herewith is a form for reporting your delegates and alternates to the American Vocational Association, Inc., 1510 H Street, N. W., Washington D. C. 20005. The delegates and alternates must be named and the list received in the AVA Office before November 9, 1964. Delegates and alternates will be checked for AVA membership.

According to our records your affiliated state association had 161 AVA members for membership year ending June 30, 1964, thus entitling your association to 2 delegates.

Either the president, secretary-treasurer, or an officially delegated representative of these offices must report to the AVA Convention Office in the Leamington Hotel, Wednesday, December 9, 1:00 - 5:00 P.M. to designate the official delegates from the list previously submitted and receive the delegate cards. Delegate cards are not being sent in advance this year.

It will be the responsibility of the representative of the state association who receives the cards to distribute them to the delegates before the meeting on December 10, 1964. Only AVA members who have been designated by the official representative of the state association and holding delegate cards will be seated.

Your attention is called to the fact that we are sending identical letters and forms to both the president and secretary-treasurer of all affiliated state associations to insure that someone in each state receives notification of this meeting. If you have changed office--making the AVA records out-of-date--please forward this letter to your successor.

Do not send in duplicate or conflicting lists from your state. Please get together to name your delegates and alternates. Thank you!

The business meeting of the AVA House of Delegates is very important to the democratic functioning of your national professional organization. We sincerely hope that every state will have its full quota of delegates and that these delegates will conscientiously represent the AVA membership from your state.

We wish to express to you our deep appreciation for your loyal support and dedication during this past year. The years ahead present many challenges to vocational and practical arts education. We solicit your continued cooperation.
