ACTIONS AND RECOMMENDATIONS OF THE

BOARD OF TRUSTEES

NEW FARMERS OF AMERICA

A. and T. College, Greensboro, N. C. January 1 and 2, 1960

Friday evening, January 1, 1960, 7:30 P. M.

Board members serving as an Advisory Committee to the North Carolina Association, New Farmers of America, met and took the following actions:

- 1. The proposed 1960 NFA Convention program as planned by the State Officers and Executive Secretary, was reviewed and approved.
- 2. Applicants recommended for the Honorary Modern Farmer Degree were discussed and approved.
- 3. The Executive Secretary's Financial Report and the Auditor's Report were reviewed, discussed and received.
- 4. It was strongly recommended that all local advisors give continued attention and promotion to the NFA Degree-Advancement, FFA Foundation Awards, and Public Relations activities, with special emphasis during NFA Week.

Saturday morning, January 2, 1960, 8:30 A. M.

The NFA Board of Trustees meeting in its regular annual session, took action as follows:

- I. 1. Received the annual report of the Executive Secretary, New Farmers of America, on the affairs of the NFA Camp for the year 1959.
 - 2. A review and analysis of the 1959 Auditor's Report was made.
 - 3. The 1960 NFA Camp Budget was reviewed, adjusted and approved.
- II. The following recommendations were approved:
 - 1. That all Chapters have good attendance at the NFA Camp during the 1960 camping season.
 - 2. That the camping fee be \$10.00 per camper for the season.
 - 3. That the camping deposit will be \$2.00 per person, refundable by sending an official notice to the Greensboro office <u>two</u> <u>days</u> before the scheduled camping date.
 - 4. That if a teacher has a party of eleven persons (boys and/or girls) attending the Camp, one of the persons may camp free of charge.
 - 5. Any Chapter or group taking girls to Camp, must have a woman Chaperon.
